Concept Attainment: **Ultra-Nationalism**

Nationalism: a complex, multi-faceted idea or concept
(keep in mind this is a 'dysjunctive' concept...one example captures all the attributes of the concept of ultra-nationalism (or nationalism)
This is also a 'sensitizing' concept in that no one definition is 'the' accepted definition.
Desiunctive is from the work of Jerome Bruner in the 1980s but has been around since the late 1900s: Sensitivine is from there it Blumer's work in the 1950s

Note:

- Feel free to exchange the examples so that they relate to your content or country.
- You also may want to add more examples; I always like to have at least 15 examples of each side and then the testers. It sometimes takes 20 or more examples before they finally pull out the key attributes of the concept.
- This power point is simply designed to illustrate how one can integrate Concept Attainment into a power point presentation



Notes re Concept Attainment

(this is a constructivist strategy...encourages analysis and inductive thinking designed by Jerome Bruner)

Three Phases

- 1. Present the focus statement to guide student thinking and then the data set (you should be prepared to show 10 to 15 Yes and 10 to 15 No examples PLUS say 3 to 5 testers)
- 2. Have them share hypotheses and do the testers...don't judge as they share...wait
- 3. Have them make connections, look for patterns to other areas...generate examples...apply what they've learned

Directions

- 1. Focus on what you think Nationalism might mean. There is no 'one right' definition of Nationalism but some aspects are common.
- 2. Compare the A Side examples and contrast them with the B Side examples
- 3. The A Side examples represent a part of nationalism; the B Side examples do not. Keep your ideas to yourself until asked to share.
- 4. You will also get 'testers' to check to see if you understand. Note: we will not own the concept or idea of Nationalism with these examples...but it will start the journey.

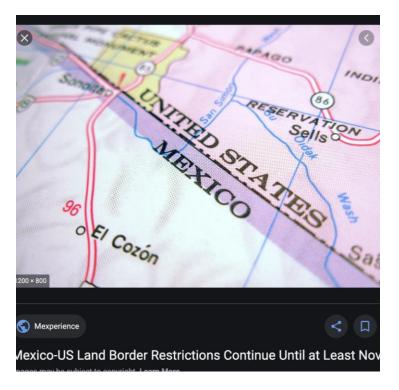
SIDE B

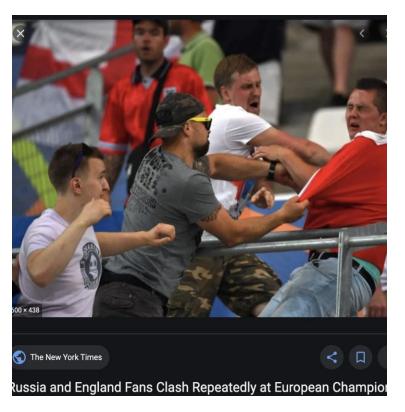


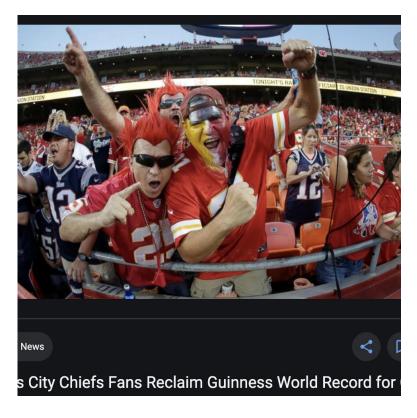




A Side – hooligans at soccer competition between England and Russia; B Side fans cheering

A side – becoming a citizen of Japan

- Having continuously had a domicile in Japan for five years or more;
- Being 20 years of age or more and having the capacity to act according to his/her national law;
- Being a person of good conduct;
- Being able to make a living through his/her own assets or abilities, or through those of a spouse or of another relative making a living;
- Not having a nationality or having to give up his/her nationality due to the acquisition of Japanese nationality; and
- On or after the date of promulgation of the Constitution of Japan, not having planned or advocated the destruction of the Constitution of Japan or the government established thereunder with force, and not having formed or joined a political party or other organization planning or advocating the same.

In short: lived here for a while, not a minor, have a steady income, pay taxes and don't commit crimes, willing to be only Japanese (i.e. no dual citizenship), not actively trying to destroy Japan.

Check for Understanding

- 1. Structure: putting the country first; power is at the heart of nationalism; often based on ethnicity and or religion
- 2. Purpose: Protect the country in terms of the economy, safety, values, beliefs etc.
- **3. Model Cases:** flying countries flags, protective tariffs, in God we trust, Christian country vs non-Christian country; Japan is Japanese, Sicily is Sicilian.
- 4. Value: identity a sense of belonging
